Officer Comments - Michael Stretton (Director Development Services)

Responses to each of the elements of the Notice of Motion have been provided below:

- Developing a strategy to identify the opportunities presented by our number one ranking in the nation with the aim of ensuring that by the end of 2013 as many people as possible in Tasmania, nationally and internationally know that Launceston is Australia's most family friendly city and that any family that is thinking of moving to regional Australia thinks of moving to Launceston; and
- Exploring the development of a targeted marketing/migration strategy, capitalising on our national number one ranking as a family friendly city, our myriad assets as a city, combined with the imminent arrival of the National Broadband Network (NBN) being activated, to attract families, workers, companies, organisations etc. from interstate and potentially overseas to relocate to the Greater Launceston Area.

There is scope to develop a strategy to capitalise on the City's family friendliness from both a tourism and/or migration perspective. Indeed there are examples of successful marketing campaigns promoting migration being run elsewhere in Australia, with one example being Regional Development Victoria, who have been running a strong digital, media and PR campaign over the last two years.

Whilst the SunCorp story has provided good coverage of this important issue, it has limitations for use as a basis for developing a marketing strategy. This was demonstrated from a local perspective by only one media representative attending the media call on Friday (18th January). Therefore, it is recommended that should the Council decide to organise and run a marketing campaign the emphasis should be moved away from 'SunCorp' to just the Family Friendly City tag line.

In considering a potential digital marketing campaign promoting migration to Launceston, Alderman need to be aware that penetration into an international market would be require a significant budget to be effective. Background as provided by Alderman Soward:

The smoke free Mall was implemented following a NOM from former Mayor and Alderman and current MLC Ivan Dean. His recent efforts in the Tasmanian Parliament in 2012 on this drew positive attention throughout the world with requests for briefings from him and media interviews as far as Ireland, France, Finland and about another 20 different countries.

The policy is self regulating- people understand the policy and as such do not smoke. Occasionally there are innocuous transgressions but by and large it is problem free.

Launceston City Council has received praise from far and wide for its position on a smoke free mall area. Other councils have followed the lead of Launceston City Council on this issue. Health and medical groups have praised Launceston for its vision and position on this issue.

I think the previous survey that was done supported the smoke free areas of malls (Brisbane Street and Quadrant) those bus transit areas and on street dining by about 75% in favour. Since this time the world has changed towards smoking, including serious discussions of introducing a smoke free generation. In fact our Government is having a report done on it by the Commissioner for Children and is to be reported on this year. There are indeed already cities in the world today with not only smoke free CBDs but whole of city smoke free areas.

The success of the smoke free Mall and the positive changes it has brought to the CBD area has given rise to the suggestion that the smoke free ban should extend throughout the CBD area. It is a natural, logical progression that reflects changing social views on smoking and the health impacts it has.

The actual boundary to be covered is to be decided after consultation with The Chamber of Commerce, City Prom and Tas Police bearing in mind the city already has clearly defined CBD boundaries that comprise the area covered by City Prom. It would be logical and sensible to use the existing boundaries that cover the City Prom area given that this area is primarily the CBD area. The consultation between the three groups and council simply gives the opportunity for logistics, local factors and physical geography to be considered and explored.

When the initial smoke free area was implemented there were some concerns from some Aldermen and sections of the community regarding the implementation and the uptake of the policy but the way the policy was gradually implemented eased any problems. I'd suggest the same model of implementation is used here in the extension of the smoke free area.

Conversations with retailers indicate great support for this NOM. Informal survey and conversation with people in the mall area indicates support for this NOM. An online survey I conducted via Facebook indicates general support for the idea with possible problems identified and some solutions suggested. I have collated it and this is contained in the report. Key issues smokers raised were for smoking areas to be clearly signed with adequate shelter, lighting and bins for butts and rubbish.

The types of smoking bins should be those that do not generate smoke or smell as some models do, that impacts on the immediate amenity for people. For the purposes of this argument there are already a number of existing areas that our council officers, Cityprom and the Chamber of Commerce would be aware of that smokers use now to smoke on their breaks, at lunch time etc. These spaces are located all across the CBD and it would simply be a matter of placing signs indicating these areas.

The implementation of this scheme will occur as the initial scheme did over time with a lead in / phased in period to enable information to be dispersed and people to become informed about this matter. The lead in period council used with the initial program was well received by the community and a similar scheme is envisaged.

Officer Comments - Robert Dobrzynski (General Manager)

Discussions have taken place with CityProm regarding a comprehensive view of smoke free areas in the central business district. A piecemeal approach to determining smoke free areas has the almost inevitable consequence of pushing smoking activity to the periphery. This results in congregations of people smoking at the border of the smoke free zones resulting in significant nuisance to businesses located in those areas, or indeed pedestrians frequenting those areas.

It was suggested to CityProm that they may wish to work with the Council in determining an area to be classified as an **Intensive Activity Zone**. This zone would be characterised by the principal retail and business locations within the central area. It would be contemplated that within the Intensive Activity Zone smoking will be banned, except in designated smoking areas that will be specifically designed to cater for smokers whilst not causing nuisance to people visiting the Intensive Activity Zone.

13.3 Alderman Soward - Notice of Motion - Extension of Smoke Free Areas in the City...(Cont'd)

In this matter a planned holistic approach can be taken, rather than merely relocating smoking activities to areas at the edge of the smoke free zone, when numerous people congregating to smoke cause a significant nuisance to nearby businesses and the public generally.

The Intensive Activity Zone determination as a smoke free area is entirely consistent with the intent of the Notice of Motion.

Officer Comments - Michael Stretton (Director Development Services)

As pointed out by Alderman Soward, the Council has been extremely pro-active in the regulation of smoking in the Launceston CBD.

Currently the Brisbane Street Mall, Quadrant Mall, two bus interchanges in St John Street are smoke free areas. Additionally, under the Public Health Act 1997 the following areas are smoke free:

- a) an enclosed public place;
- b) an enclosed workplace;
- c) any area not within private premises designated by the occupier of the area as a smoke-free area:
- d) at an outdoor sporting venue during an organised sporting event being held at that venue, anywhere within 20 metres of
 - i. any permanently or temporarily erected public seating; or
 - ii. any seating, marshalling area, warm-up area, podium or other part of the venue reserved for the use of competitors or officials; or
 - iii. any part of the venue used to conduct the actual organised sporting event:
- e) anywhere within 3 metres of an entrance to or exit from any non-domestic building or multiple-use building;
- f) anywhere within 10 metres of any air intake for ventilation equipment on or in a multiple-use building or a non-domestic building;
- g) anywhere within 10 metres of any play equipment erected at a children's playground in a public place;

- h) on a beach at which a surf-lifesaving organisation has temporarily erected a pair of red and yellow flags for the safety of beach users, the area "between the flags" (being the rectangular area bordered by the flags, the water's edge and the landward fringe of the beach);
- i) anywhere at a public swimming pool, including the curtilage of the public swimming pool;
- anywhere that the Director, by public notice, designates as a smoke-free area in connection with a public event or class of public events specified in that public notice;
- k) anywhere in an outdoor dining area;
- I) anywhere within 3 metres of an outdoor dining area that is not surrounded by a screen, or other barrier, that is at least 2.1 metres high and impervious to smoke:
- m) a public street that the regulations declare to be a pedestrian mall;
- n) a public street that the regulations declare to be a bus mall;
- o) anywhere within 3 metres of a bus shelter on a public street.

An extension of the smoke free areas in the wider CBD area can be considered under the provisions of the Public Health Act 1997.

Recently Council staff have been meeting with a group comprising Tasmania Police, Cityprom and business representatives to discuss potential actions following complaints of anti-social behaviour in the CBD. These discussions have included some consideration of an extension of the existing smoke free area. It is suggested that this group could consider the matter and make a recommendation back to Council in respect of the preferred future boundary of the smoke free area.

I think the previous survey that was done supported the smoke free areas of malls (Brisbane Street and Quadrant) those bus transit areas and on street dining by about 75% in favour. Since this time the world has changed towards smoking, including serious discussions of introducing a smoke free generation. In fact our Government is having a report done on it by the Commissioner for Children and is to be reported on this year. There are indeed already cities in the world today with not only smoke free CBDs but whole of city smoke free areas.

The success of the smoke free Mall and the positive changes it has brought to the CBD area has given rise to the suggestion that the smoke free ban should extend throughout the CBD area. It is a natural, logical progression that reflects changing social views on smoking and the health impacts it has.

The actual boundary to be covered is to be decided after consultation with The Chamber of Commerce, Cityprom and Tas Police bearing in mind the city already has clearly defined CBD boundaries that comprise the area covered by Cityprom. It would be logical and sensible to use the existing boundaries that cover the Cityprom area given that this area is primarily the CBD area. The consultation between the three groups and council simply gives the opportunity for logistics, local factors and physical geography to be considered and explored.

When the initial smoke free area was implemented there were some concerns from some Aldermen and sections of the community regarding the implementation and the uptake of the policy but the way the policy was gradually implemented eased any problems. I'd suggest the same model of implementation is used here in the extension of the smoke free area.

Conversations with retailers indicate great support for this NOM. Informal survey and conversation with people in the mall area indicates support for this NOM. An online survey I conducted via Facebook indicates general support for the idea with possible problems identified and some solutions suggested. I have collated it and this is contained in the report. Key issues smokers raised were for smoking areas to be clearly signed with adequate shelter, lighting and bins for butts and rubbish.

The types of smoking bins should be those that do not generate smoke or smell as some models do that impacts on the immediate amenity for people. For the purposes of this argument there are already a number of existing areas that our council officers, Cityprom and the Chamber of Commerce would be aware of that smokers use now to smoke on their breaks, at lunch time etc. These spaces are located all across the CBD and it would simply be a matter of placing signs indicating these areas.

The implementation of this scheme will occur as the initial scheme did over time with a lead in / phased in period to enable information to be dispersed and people to become informed about this matter. The lead in period council used with the initial program was well received by the community and a similar scheme is envisaged.

To consider a Notice of Motion regarding investigating issuing green waste bins to Launceston City Council households.

NOTICE OF MOTION:

That Launceston City Council investigate issuing all households within the Launceston City Council area with a Green Waste bin to be used for green waste [garden clippings, prunings, lawn clippings etc] to be collected on a monthly basis. It is proposed this scheme becomes effective in the 2013/14 financial year.

REPORT:

Alderman Soward will speak to the Notice of Motion.

Background as provided by Alderman Soward

A number of mainland councils already do this so it is not a new thing but relatively new for Tasmania. Many people do not have a utility or trailer to take away green waste and it simply mounts up in their backyards providing a haven for vermin like rats and mice.

It would also ensure that garden waste was not put into our other waste which we know it is at present as well as reducing the incidences of waste dumping.

The frequency of bin collection would perhaps not need to be as high as rubbish collection (weekly) or recyclable collection (fortnightly). I'd leave suggested frequency open for discussion but would think a monthly service would suit the vast majority of ratepayers and residents.

Officer Comments - Harry Galea (Director Infrastructure Services)

At the meeting on 10 December 2012 Council adopted the Interim Strategy & Action Plan on waste management. Also Council resolved to adopt the specific recommendations in the Interim Strategy & Action Plan (ISAP) being:

- adopt the Launceston Resource Recovery and Waste Management Interim Strategy and Action Plan as the interim strategy to guide Council's waste management activities for the following 2 years
- approve calling for expressions of interest to find a suitably qualified operator for a resale shop. A future report will seek Council approval of the scale of infrastructure and cost to action a resource recovery centre and resale shop.
- develop, over the next 18 months, an education campaign to raise awareness about recycling, waste avoidance, reuse and the importance of source separation
- commence preparation of a long term strategy for Launceston within two years of this interim strategy being adopted by Council
- consider incentives to encourage better source separation and recycling by the community, and
- undertake work into considering home composting options and a kerbside organics collection service for households in Launceston

The initiative to investigate the introduction of a kerbside organics service has direct synergies with the introduction of a regional composing facility at the Launceston Waste Centre. A successful composting facility must have approximately equal portions of carbon rich waste (i.e. green leafy waste) and nitrogen rich waste (biosolids and food waste). It is highly likely that the kerbside organics wheelie bin would be collected weekly, residue rubbish (mainly inert) waste collected fortnightly and retain the fortnightly recyclables collection service.

To implement the service as proposed in the notice of motion, without the composting facility and without sourcing appropriate quantities of bio-solids/food waste, will mean that the material will be chipped and be used as a soil substitute to cover the landfill with the excess disposed as landfill waste. This service would cost \$660,000 p.a. (cost includes for 26,000 tenements - 12 collections per annum, bin depreciation, LWC fees). This equates to an increase in the annual waste management charge of \$25.40 plus administration costs and carbon tax.

Uncomposted greenwaste would contribute to Council's carbon tax liability. Mulched greenwaste is unable to be disposed/sold to the community due to the mulch being untreated thereby risking the spread of pathogens and plant propagules. It is not cost effective to sterilise greenwaste to allow public sale/disposal.

The requirements of the Notice of Motion are unlikely to be achieved due to the planning, procurement and implementation for a scheme to be introduced for 2013/14. It is anticipated that the investigation into a kerbside organics collection service will be concluded and reported back to the Council for consideration by mid 2013.

Background as provided by Alderman Soward:

Whenever a disaster befalls us we must learn from it. It appears the issues around lack of telecommunications and mobile coverages has not been learnt - in the aftermath of Port Arthur then Prime Minister Howard noted the terrible lack of mobile coverage in the area and now in the wake of the bushfires the exact same problem has been noted. No action had been taken to alleviate this problem despite it being identified as part of the extensive review of that horrendous incident.

This Notice of Motion is important particularly in the context of Launceston where residents of heavily forested areas like Lilydale, Turners Marsh, Nunamara, White Hills, Blessington and Upper Blessington have less than satisfactory mobile phone coverage and would be at severe risk in the case of a bushfire. Recent travels through these areas see areas that are within 40km of the Launceston CBD having next to no or no mobile coverage at all. In the event of a disaster the residents have no ability to contact family members or relatives warning them of impending disaster.

Upgrading coverage is a must - it is foolhardy not to learn from the disaster that befalls others. If such a disaster happened in Launceston's municipal boundaries our residents would find themselves in the same predicament as those in Dunalley and surrounding areas in terms of no mobile communication with the outside world and as such would be at serious risk of loss of life.

Officer Comments - Robert Dobrzynski (General Manager)

The issue of telecommunications coverage in fire prone areas has taken a far more critical role following the disastrous Black Saturday bushfires in Victoria and subsequent bush fire events across Australia.

From previous discussions while in Victoria, I understand that Telstra have the capacity to install temporary mobile phone coverage towers in areas of high bushfire risk, in order that text messaging via the national standard can be received by households.

The issue which is the subject of Alderman Soward's Notice of Motion becomes one impacting significantly on the capacity of residents in areas under bushfire threat to leave in a timely manner to prevent injury or fatality.

Often, the first casualty of a bushfire or the high winds experienced with days of extreme fire risk is that land lines cease to operate effectively. This then provides a heavy reliance on text messaging via the mobile phone network to ensure early warning to residents to activate their bushfire emergency plan. If mobile phone coverage is not available, residents in areas of high fire risk are placed in enormous danger during days of extreme fire risk.

My understanding from negotiations undertaken whilst in Victoria is that ongoing discussions where occurring between Telstra, the State Government and the Commonwealth to jointly fund mobile phone tower facilities provided by Telstra that would enable significant mobile phone coverage in high bushfire risk areas where such services are currently not available.

13.5 Alderman Soward - Notice of Motion - Telecommunications...(Cont'd)

The technology and capacity exists to make this happen. What is currently lacking appears to be the political will.

Officer Comments - Rod Sweetnam (Director Facility Management and Governance Services)

When there is a threat of bushfire the Tasmania Fire Service has the capacity to send warning text messages via the Telstra network to anyone with a mobile phone in the area that may be impacted by the fire threat. It is self evident if there is no infrastructure to support mobile coverage in an area then this service can not be provided. On this basis the Notice of Motion is worthy of support.

Background as provided by Alderman Soward

The area known as the Avenue is a popular coffee shop/retail strip in the city. It features an attractive ambience that is impacted on by motor vehicles including trucks travelling through it. It is a natural progression to close it to traffic - it is a cobblestone "street" and provides atmosphere to the city area. It also links the Quadrant Mall and the Brisbane Street Mall so is a logical area to be closed off.

The mall area would enable Council in conjunction with Cityprom and the Launceston Chamber of Commerce to add value and atmosphere to the central city area. Additional seating, small trees and shrubs could add amenity to the area and provide comfort for shoppers and others. There have also been suggestions mooted about using the area as a market type space on occasion once again adding to the culture of the city and getting people into the city centre. This suggestion has much merit given we try and encourage people to come into our city and support our local retailers- markets and the like bring a different feel into the city as evidenced by other markets that are held in the city from time to time as part of various promotions etc.

The current arrangement of traffic through this area is a bit of a mess- it impacts on people enjoying the cafe style outdoor atmosphere and brings nothing really to enhance traffic movements through the city. Traffic would still be able to use St John Street as it does at the moment but without the turn into Brisbane Street obviously.

Investigation of the impacts of the closure will enable any decision on the area to be made with vision and will take into account views of key stakeholder groups such as the Chamber of Commerce, Cityprom, Metro, Tasmania Police as well as our own residents and ratepayers.

There is mixed opinion on this issue amongst the business community and amongst shoppers so an investigation such as this will serve to inform the debate and to ensure that all voices are heard and impacts more clearly understood before council decides to take any action on the issue.

Officer Comments - Robert Dobrzynski (General Manager)

A critical element of the Greater Launceston Plan relates to the development of a Central Area Strategy. The central area extends from Tamar Street, to the North Esk River, Howick Street and west of Bathurst Street.

The brief for the Central Area Development Strategy refers to the regional role of the Launceston CBD and Central Launceston. It also refers to the recent urban design study by Gehl and the Launceston Retail Audit and Activity Centres Strategy.

13.6 Alderman Soward - Notice of Motion - The Avenue...(Cont'd)

The request for tender indicated:

Given the diverse regional service role of the Launceston CBD and its importance to the greater Launceston area and extended region, a holistic strategy for the sustainable development and coordinated revitalisation of the Launceston Central Area is considered to be a project of state and regional significance.

The principle objective of the Central Area Strategy is to provide a strategy encompassing an investment and comprehensive master planning and urban design framework to guide the sustainable development of the Launceston Central Area as a diverse mixed use precinct.

The supporting objectives indicate the need for the study to:-

- Take a broad future time period (25 years) as the basis for the assessment of longer term needs;
- Provide and assessment of activity requirements for the central area;
- Take account of public transport and road planning;
- Provide a focus on pedestrian spaces, amenity and connectivity requirements;
- Provide an implementation framework linked to an investment strategy;
- Provide a holistic master plan and urban design framework.

As can be seen in the foregoing, consideration of the urban design characteristics, infrastructure requirements, pedestrian permeability and traffic management arrangements related to the Launceston CBD will form an integral and crucial part of the Launceston Central Area Development Strategy.

The Council has previously resolved to investigate the extension of the current mall area into the area known as The Avenue in Brisbane Street.

It is the intention to incorporate these considerations and the clear desire for the Council to establish The Avenue as a mall area into the work undertaken by David Lock and Associates to establish the Launceston Central Area Development Strategy as a fundamental aspect of the Greater Launceston Plan.

It is considered that in this manner urban design considerations relative to the CBD can be considered in a holistic manner.

14.1 Local Government Miscellaneous Amendments Bill

DECISION STATEMENT:

To provide comments on the Local Government Miscellaneous Amendments Bill to the LGAT.

PREVIOUS COUNCIL CONSIDERATION:

28 March 2012 - LGAT General Meeting Resolution on Local Government Act nuisance provisions.

RECOMMENDATION:

That the Council make the following comments to the Local Government Association of Tasmania in respect of the *Local Government Miscellaneous Amendments Bill:*

- The Council has no comments in respect of the electoral provisions or other proposed minor changes to provisions of the Act;
- The Council is generally supportive of improving Local Government's ability to effectively deal with dilapidated buildings;
- The definition of dilapidated buildings or structures should relate only to the impacts that a dilapidated building or structure has on amenity, rather than having to determine any loss a dilapidated building may be causing in the resale value of surrounding/adjoining premises;
- To improve consistency of decision making the definition of *dilapidated buildings or structures* should provide a series of 'guidelines' or 'tests' to determine if a building or structure is prejudicial to amenity of surrounding/adjoining premises;

14.1 Local Government Miscellaneous Amendments Bill...(Cont'd)

- The proposed process for actioning dilapidated buildings or structures is unwieldy. Given the subjectivity of the assessment on whether a building or structure is dilapidated, and in the interest of natural justice, it does not seem appropriate for a General Manager to serve a Building notice on a property owner on the grounds that a building may be dilapidated. It is suggested that it would be more appropriate to refer such matters directly to the Council for a decision and that any action would follow a Council decision that a building is dilapidated in accordance with the Act; and
- The Bill should be expanded to include an amendment to both the *Local Government Act 1993* and the *Resource Management and Planning Appeal Tribunal Act 1993* to confer jurisdiction for the nuisance provisions (Sections 199 204 of the LGA 1993) to RMPAT rather than the Magistrates Court.

REPORT:

The LGAT have requested that the Council provide comments on the *Local Government Miscellaneous Amendments Bill* ('the Bill') which has been released by the State Government for consultation purposes.

The Bill proposes amendments to the *Local Government Act 1993* and minor consequential amendments to the *Building Act 2000* to provide:

- Councils with the power to take action to rectify issues with dilapidated buildings;
- Additional powers under the nuisance provisions to allow councils to issue infringement notices;
- Clarity to the electoral provisions of the Act and
- Clarity to a small number of other provisions of the Act.

The purpose of this report is to provide a basis for Council to provide comments on the Bill.

Electoral provisions

Council's Manager Corporate Strategy advises the Amendment Bill allows for amendments to be made to the Local Government Act in relation to the electoral provisions, by-law provisions and some minor technical fixes.

14.1 Local Government Miscellaneous Amendments Bill...(Cont'd)

The amendments to the electoral provisions are not substantive in nature, they include:

- amendment of definitions:
- -clarification of a person's entitlement to be on the list of electors and to vote in an election;
- clarifies the General Manager's electoral roll provisions;
- amendment to make it an offence for a candidate who has been provided with a copy of the list of electors, to use that list except for a purpose in connection with the election:
- adds an offence provision to restrict use of a council's logo in electoral advertising; and
- amends to allow procedures for voting by email for people who are outside Tasmania.

The amendments to the by-law making provisions are matters of a technical nature only and do not substantially change the by-law making process.

It is not recommended that Council makes formal comment in relation to the miscellaneous amendments proposed as part of the Local Government Miscellaneous Amendments Bill.

Dilapidated Buildings or Structures

The current *Local Government Act 1993* nuisance provisions and the *Building Act 2000* allow Councils to act to abate a risk from a dilapidated building only where it causes, or is likely to cause, danger or harm to the health, safety or welfare of the public; a risk to public health; or is, or is likely to be, a fire risk. However, these provisions do not allow Councils to require that works be undertaken to address buildings on the basis that they are unsightly.

For many years Local Government in Tasmania has been lobbying the State Government for the development of legislation to deal with derelict, dilapidated or unsightly buildings. Most recently, the following motion was passed by Council's at the LGAT General Meeting in July 2011:

"That LGAT again strongly request the State Government to pass amending legislation to give Councils clear and appropriate powers to enforce works to remedy the adverse effects of derelict or dilapidated buildings on the streetscape and nearby properties"

In response to this requests (and previous requests) the State Government has prepared the Bill.

14.1 Local Government Miscellaneous Amendments Bill...(Cont'd)

The Bill proposes to expand the definition of nuisance to include dilapidated buildings and provide Councils with appropriate powers to enforce works to remedy the adverse effects of dilapidated buildings on the local community.

The proposed amendments will provide Councils with the power to order owners of buildings to carry out building work in relation to dilapidated buildings. The building work ordered could include repair or demolition of the dilapidated building.

The key proposed amendments to the Local Government Act are to:

- Insert a definition of dilapidated buildings;
- Require a general manager to consider any building owner representatives relating to the building notice prior to requesting that the Council consider the matter;
- Require a general manager to provide all building owner representations to the Council;

Under the proposed Bill the dilapidated building process would be as follows:

Dilapidated Buildings - Process

GM identifies that a building (or temporary structure) may constitute a dilapidated building and undertakes relevant checks to see if existing heritage, planning, environmental or structural issues are relevant.



Building Act section 163 GM issues a Building Notice



Building Act S.168

Owner can make representations to the GM as to why the building should not be considered a dilapidated building that requires works.



Building Act S.169

GM can revoke the Building Notice after considering the representations, if appropriate to do



GM refers the matter to the Council, including any representations received, to determine if the building is a dilapidated building and to determine what building works should take place to rectify the building (i.e. repairs or demolition).



Local Government Act section 184

Council decides that the building is a dilapidated building and determines what action should take place, or council rejects the GM's recommendation.



Building Act section170

If the council decides that the building is dilapidated, the GM implements the council's decision by issuing a Building Order. If the council rejects the recommendation, the GM revokes the Building Notice



Building Act section 211

Building owner may appeal to the The Resource Management and Planning Appeal Tribunal (RMPAT) agains<u>t th</u>e Building Order



Building Act section192

Council can carry out the work if the Building Order has not been complied with



Building Act S.194

If the council demolishes a building under section 192, the council can recover the costs from selling the building supplies.

Council staff have reviewed the Bill and whilst they are generally supportive of improving the Council's ability to effectively deal with dilapidated buildings, the following comments are offered:

- Under the Bill a dilapidated building or structure means:
 - "a building, or temporary structure, that, because of neglect or damage, is of an appearance, or structural condition, that is prejudicial to
 - a) the interest, of an owner of premises that share a boundary with the land on which the building or structure is situated or that are situated opposite that land, in maintaining the resale value of the premises; or
 - b) the amenity of persons who reside in premises referred to in paragraph (a)";

Council staff have reviewed the Bill and whilst they are generally supportive of improving the Council's ability to effectively deal with dilapidated buildings, the following comments are offered:

- Under the Bill a dilapidated building or structure means:
 - "a building, or temporary structure, that, because of neglect or damage, is of an appearance, or structural condition, that is prejudicial to
 - the interest, of an owner of premises that share a boundary with the land on which the building or structure is situated or that are situated opposite that land, in maintaining the resale value of the premises; or
 - d) the amenity of persons who reside in premises referred to in paragraph (a)";

This definition is very open and subjective and will prove difficult to consistently apply.

In determining compliance with (a) it is unlikely that a Council could rely on its own assessment in respect to the potential loss in resale value of premises. It would be necessary to engage advice from a qualified valuer and this cost would need to be borne by the Council. It is suggested this provision should be removed and the decision on whether a building or structure is dilapidated be based only on compliance with (b) subject to the following recommended change:

Under (b) the Council would need to determine if a dilapidated building or structure is prejudicial to the amenity of persons who reside in the adjoining/surrounding premises. This is an extremely broad power and there is little guidance provided as to what state a dilapidated building or structure must be in to be prejudicial to the amenity to the owners of adjoining/surrounding premises. It is suggested that this provision would be enhanced if it is provided with a series of 'guidelines' or 'tests' to determine if a building is prejudicial to amenity;

• The proposed process to administer bill is unwieldy. Under the proposal a General Manager must make an initial decision as to whether a building (or temporary structure) may constitute a dilapidated building and then, following an opportunity for the owner to make a representation, refer the matter to the Council for a decision on whether a building is dilapidated. It would then be beholden on the Council to determine whether the building is dilapidated and what building works should take place to rectify the building.

Given the subjectivity of this assessment and in the interest of natural justice, it does not seem appropriate for a General Manager to be serving a Building Notice on a property owner the grounds that a building <u>may</u> be dilapidated. It is suggested that it would be more appropriate to refer such matters directly to the Council for a decision and that any action would follow a Council decision that a building <u>is</u> dilapidated in accordance with the Act.

The Council successfully moved the following resolution at the LGAT General Meeting in March 2012, "That LGAT request the State Government to amend the respective legislation (the *Local Government Act 1993* and the *Resource Management and Planning Appeal Tribunal Act 1993*) to confer jurisdiction for the nuisance provisions (Sections 199 - 204 of the LGA 1993) to RMPAT rather than the Magistrates Court.". This Bill does not achieve this outcome and it is suggested that it be incorporated. Whilst it is noted that appeals concerning dilapidated building will be able to be made to the RMPAT under the Building Act 2000, the Bill does not address the fact that other Local Government Act nuisances (such as unsightly articles) must still be determined in the magistrates court.

The motions passed at the 3 December 2012 Annual General Meeting were considered at the 10 December Council meeting. Council resolves to defer the items to allow officers to research the requests and prepare report and recommendations.

The resolutions passed at the AGM on 3 December 2012 together with the officer comments are:

6.1.1 Moved Robin Smith, Seconded Jeanette Smith

That this Council considers locating planter boxes at each end of the Brisbane Street Mall to provide some visual and sound separation between the passing traffic and the Mall.

Officer Comment:

There are no in principle objections to the erection of planter boxes subject to location, design and budget considerations. Any planning for installations in the Mall will need to be considered in the context of the Greater Launceston Plan recommendations regarding the Central Activities District. There will be costs associated with the planter boxes, both capital and maintenance, in which case the project could be deferred until redevelopment of the Mall in 12 (or more likely 24) months time. Given the time frame the temporary planter (and accompanying bollards to control vehicles) could be installed at this time.

Recommendation:

That the concept is supported and to be considered during the redevelopment of the Mall as part of the Greater Launceston Plan and for the period leading to the redevelopment of the Mall that planters (and bollards to control vehicles) be installed at either end at an estimated value of \$14,000.

6.1.2 Moved Robin Smith, Seconded Jeanette Smith

That Council convert a further two Controlled Vehicle Loading Zones to 15 minute Zones on Sundays in the CBD.

Officer Comment:

There are many short term parking zones in the CBD. Rather than convert loading zones to fifteen minute zones on Sundays, it is recommended the fifteen minute zones already in place in the CBD be further utilised. For example, there is a fifteen minute zone in the Avenue that does not operate on Sundays. To change this fifteen minute zone to seven days per week would be ideal as many of the businesses in the Avenue rely on short term pick up and drop off parking such as the coffee shops, bakers and chemists. The Manager: Parking Operations and Carr Villa Memorial Park has discussed this issue with the business operators that operate on Sundays near this fifteen minute zone and he received 100% support for the recommended change.

Recommendation:

That Council agrees to extend the operating hours of two fifteen minute parking zones in the Central Business District (CBD) to seven days operation.

6.1.3 Moved Robin Smith, Seconded Jeanette Smith

Henceforth, Launceston City Council add the laneway connecting Charles Street to Dechaineaux Way (AKA Birchalls Carpark) to its street cleaning rota for cleansing to the standard as if it were a Council owned or operated laneway.

Officer Comment:

Council's Cleansing group undertake early morning street cleaning of public streets in and around the CBD. Their daily program includes Dechaineaux Way which is a public street maintainable by the Council. Also Council has a contract with the owner of the 'Birchalls car park' and this is cleansed on the basis of 3 days each week.

Council also had a contract with the owner of the land (noted above as the 'laneway' between Dechaineaux Way and Charles Street) to cleanse the land on a do and charge basis once each week. The owner of the land terminated that arrangement in the last 12 months. The subject land is part of the freehold title with private access rights in favour of the immediate neighbouring properties.

On this basis Council should not undertake the cleaning of this private land.

Recommendation:

That the request is not supported for this private land.

6.1.4 Moved Robin Smith, Seconded Jeanette Smith

That Council mark an identifying number adjacent to non covert Council operated CCTV cameras on streets.

Officer Comment:

The Launceston City Council does not monitor the CCTV network covering the public areas of the Launceston CBD. This network is exclusively used by Tasmanian Police. Council assist in providing this service by funding the network infrastructure upgrade and maintenance works, in consultation with the network user.

Council Officers have consulted Tasmania Police with regard to the effectiveness of providing signage at each CCTV location within the Launceston CBD. They have advised that CCTV numbering is not used elsewhere in the State, and would not be their preference to implement this system in one jurisdiction. They have advised that:

 Each camera location is identified on their system by both spatial geo-coordinates, and locality descriptors.

- Cameras are not often mounted in obvious locations (to the general public), therefore implementing legible signage (or signage that is clearly linked to a camera position) may be challenging.
- Tasmania Police's preference is to rely on more obvious location descriptors such as Street names, shop localities or other easily identifiable landmarks.

Recommendation:

That Council accept the advice of Tasmanian Police, and not proceed with the installation of identification signage of the CCTV network in the Launceston CBD.

6.1.5 Moved Robin Smith, Seconded Jeanette Smith

That Council explore alternative or additional on-street loading zones close to each end of the Brisbane Street Mall for heavy vehicles serving the Mall.

Officer Comment:

There are five loading zones at the Charles Street end of the Mall between York Street and Paterson Street, two within approximately thirty five metres of the Mall itself. The St John Street end of the Mall has three loading zones within approximately thirty five meters from the entrance to the Mall. Three parking spaces would need to be removed to accommodate another loading zone and this may prove to be a disadvantage to businesses in the area.

Recommendation:

That there be no change to the current situation regarding the number of loading zones near either entrance to the Mall.
