I read with alarm of a development application for a Theatre at 217B Invermay Road. I am the owner of which is currently rented out however I do intend to live in the property soon.

My concerns are as follows:

- 1. Noise
- 2. Hours of use
- 3. Smell from the micro-brewery
- 4. Traffic
- 5. Parking
- 6. The number of days of use

I detail my concerns for each of these issues below.

1. Noise

I am greatly concerned that the noise reported has "the potential to exceed the assessment criteria". It seems that under the proposed use residents of Waugh Street will suffer from exhaust noise at up to 40db. This would be similar to the sound of being right next to a fridge in our own backyards, in a quiet suburban street. It is totally unacceptable to introduce this kind of continual noise into residential backyards. It will be the kind of noise that, once heard, cannot be "unheard" – we will notice it every time we step outside!

2. Hours of Use

The proposed development will intrude on residents for 17 hours per day, 7 days per week, which is excessive. This will leave us only 7 hours per day of down time – and those 7 hours will be when we are asleep! For all of our waking hours there will be exhaust fans, smell, and traffic problems coming from this site, especially when compared to its current use. The "extra 30 minutes" to 10.30pm is mentioned as making "little difference" – presumably the producer of the report doesn't need much sleep or downtime! It's also the personal opinion of someone who will be unaffected by the development and it has no place in a technical report.

3. Smell from the micro-brewery

There is little discussion in the paperwork provided of the smell from the micro-brewery – it seems to be dismissed. Yeast smells like urine. I presume there are to be stringent safeguards against the smell escaping, and regular testing of the brewery and surrounding suburb.

4. Traffic

My concern about traffic is the number of people that will drive into Waugh Street looking for a park, then have to turn around and come back out when they can't find anything. People will be driving into our driveways to turn around when they find that Waugh Street is in fact a cul de sac, with resultant lights blaring into our windows of an evening.

5. Parking

The report notes 115 available parking spaces nearby. Does this take into account the residents using the parking, or is this just the total number of available parking spaces? You should note that residents may wish to park in their own street! I don't actually drive, so it's not an issue for me personally, but it is of concern to the residents of Waugh Street and one that the development application seems suitably vague about.

6. Days per week of operation

For the theatre to operate 7 days per week is quite excessive! Residents will surely need a break from the constant noise, smell, additional visitors to the area, parking problems and traffic. This is going to be a huge intrusion into our lives and to have it occur every single day of the week is a massive burden on residents of Waugh Street. With a population the size of Launceston, surely 3 to 5 days is enough for the site to operate – perhaps 3 days for the theatre and 5 days for the cafe.

It should be noted that just because we did something one way a long time ago, it doesn't mean that we should automatically do the same thing again. There are plenty of other uses that would be more suitable, including the current approved use as a retail outlet. The CBD should be the location for noisy entertainment venues, not the suburbs.

This development has the potential to completely destroy the liveability of nearby streets and would be highly disruptive. It may well mean that I would have to sell my property and buy elsewhere.

I plan to move to Tasmania to get away from all of the noise and activity of Sydney. I realise that Tasmania feels the need to grow, but Launceston City Council can and should show wisdom and farsightedness when considering the growth and development of the City. The amenity of the many residents affected by this development should be considered ahead of one developer's profits.

Economic Impact

In 2014 BOFA-generated income from interstate and intrastate visitors to Launceston and local supplier purchases was an estimated \$994,335 comprising:

- A \$769,335 inflow of purchasing from the visitors to the festival on local tourism, accommodation, food and other spending (excluding tickets and merchandise). This comes from the 1,179 estimated mainland/international visitor nights generating \$169,383 and 4,176 intrastate visitor nights generating \$599,952, using the typical \$431 value of visitors over three days at rural festivals.
